SUPPORTING MEMBERSHIP TERMS

Upon acceptance of this Membership Application by the National Shooting Sports Foundation, Inc. (“NSSF”), Supporting Member agrees to comply with the following terms and conditions of membership:

1. Bylaws & Membership Rights: Supporting Membership rights and privileges in the NSSF shall at all time be subject to the Bylaws of the Foundation. Supporting Members shall have all the rights and privileges extended to them under the Bylaws but shall have no voting rights in the Foundation.

2. Term of Membership: Membership in the NSSF is for one (1) full year commencing on the date of acceptance of this application by NSSF and shall renew thereafter for additional one (1) year terms thereafter upon full payment of all dues.

3. Membership Dues: Supporting Membership dues are established annually by the NSSF Board of Governors and may be adjusted from time to time as needed to support the operations and mission of the Foundation and can take the form of a special assessment. Supporting Membership dues must be paid promptly in full upon initial application or renewal to avoid suspension or expulsion from membership. Supporting Members shall continue to be members in good standing until 60 days after receipt of written notice requesting payment of dues owed to the Foundation.

4. Suspension, Expulsion & Resignation: Non-payment of dues and other conduct detrimental to the best interests of the Foundation shall be grounds for immediate expulsion from Supporting Membership. The NSSF Board of Governors may upon request of the Supporting Member and for good cause shown suspend the member, extend the time for payment of dues or take such other action as the Board of Governors deems appropriate.

Unless otherwise provided for by the NSSF Board of Governors, an expelled member shall remain obligated to pay dues owed at the time of expulsion.

Any member may resign at any time; however, such member shall remain obligated to pay dues owed at the time of resignation. No member who resigns or is expelled from membership shall have any claim for refund of any contribution or have any interest in or right to any assets of the Foundation.

5. Trademark Usage: Members in good standing are granted the non-exclusive, non-transferable, royalty-free right to use the National Shooting Sports Foundation® registered name and logo to promote their membership in the Foundation. Members agree that they will do nothing inconsistent that might harm NSSF or NSSF’s ownership rights in its name and logo. Each member agrees to use NSSF’s name and logo only as prescribed by NSSF and not to use the name and logo in any manner that expresses or implies, or could be construed to express or imply, that the NSSF endorses or certifies a member’s products, services or opinions, or in any manner that misrepresents, or has the appearance of misrepresenting, the relationship between a member and the NSSF other than a member-trade association relationship. Members who fail to maintain their membership must immediately discontinue any and all use of NSSF’s name and logo.
