Please Note:

- The safe program is supported and approved by most jewelry insurance companies. Consult with your jewelry insurer to advise you regarding the safe(s) that will be in compliance with your JCK Show coverage.
- Upon placing your safe order with your JCK Sales Representative, Jan Choplin – Rolland Rental Safe Coordinator – will fax or email a Safe Installation Instruction Form. Exhibitors are required to provide Rolland Safe with a booth layout showing exactly where the safe is to be installed.
- Safes are installed well in advanced of Product Only Day. If you request repositioning of the safe **on or after Product Only Day**, there will be a minimum additional labor charge of \$150.
- Safe rental deadline is April 17, 2008.
- JCK Las Vegas will invoice you for the safe rental.

Rental Safe Insurance Compliance

Each of the rental safe options fall in one of two distinct security levels: the TL30 High Security Burglary rating or the non-UL rated "Class B" safe. To determine which security level is in compliance with your individual show insurance policy, Reed Exhibits and Rolland Safe Company **strongly advise you to consult with your insurance carrier prior to submitting your order.**

Individual insurance companies and policies have different coverage parameters for trade shows. The following Jewelers Mutual Letter is *one example* of a major insurance company's guidelines for coverage during the JCK Las Vegas Show. Even if you are not a Jewelers Mutual customer, this letter may be of help in guiding the discussion between you and your insurance agent.

Terms and Conditions

Payment is due in accordance with the payment schedule on page one of the Application & License Agreement for Exhibition Participation (your booth contract). When Safe Rentals are reserved after the 100% due date, payment will be due in full with initial invoice. All orders with this rental agreement form are non-cancelable and non-refundable.
